2	Substance (GSM): CB 55-56 GSM; CFB 50-52 GSM; CF 55-56 GSM Allowable percentage of tolerance for grammage: $\pm 5\%$	
3	Roll Width (RW): 14" R.W. and 9.5" R.W.	
4	Core Size: 3"	
5	Length per Roll: 6,000 linear meters (standard) per roll Allowable percentage of linear meter per roll: $\pm 10\%$	
6	Density: must be even	
7	Visible Fiber Strands: Embedded, color red and blue, size 3mm to 6mm	
8	Invisible Fiber Strands: Embedded, fluorescent blue, size 3mm to 6mm
